

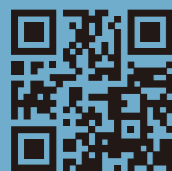

## 一、项目简介

国际金融硕士项目(Master of International Finance, 简称MIF)主要针对政府中、高级官员, 金融机构和企业的中、高层管理人员而设计。该项目旨在配合“一带一路”国家战略, 为加快推进亚洲国家经济发展与区域经济一体化进程提供人才支撑, 持续发挥国际多边金融机构核心竞争力储备人才资源。重点培养具有全球战略眼光的区域合作政策制定者和执行者, 能够加速推进亚洲经济一体化进程的金融管理人才, 能够促进亚洲区域互联互通的企业家。

该项目主要依托对外经济贸易大学金融学院雄厚的师资力量和丰富的教学经验, 通过一年制全英文教学, 学员将系统掌握开发性国际金融合作的相关理论和实践, 了解“一带一路”国家的经济政策环境, 把握国际经济合作的发展趋势, 同时加深对中国金融、法律、文化和政治体系的理解。

## 二、对外经济贸易大学简介

对外经济贸易大学(简称UIBE)创建于1951年, 地处北京奥运商圈, 是中国教育部直属的全国重点大学、国家“211工程”首批重点建设高校、中国商务部与教育部共建院校, 也是中国政府批准的双一流重点建设高校。

UIBE倡导追求卓越和创造精品, 以成为国际知名有特色一流大学为长期愿景和历史使命。学校是一所拥有经、管、法、文、理、工六大门类, 以国际经济贸易、国际经济法、国际金融、工商管理、商务外语等专业为优势的多科性财经类大学, 是中国首个在本、硕、博学历层次同时拥有中、英文授课培养体系的高等院校, 现已有84个专业招收并培养来华留学生, 其中的29个专业实现了全英文授课。

UIBE是目前中国唯一一所同时获得EQUIS、AACSB、CAMEA和AMBA认证的财经类大学, 也是第一所获得AACSB国际认证的“211工程”重点大学。2018年, 学校国际学生数量占在校生总规模的比例在中国大陆地区排名第一, 毕业生就业率全国排名第二, 薪酬涨幅全国第一, 中国毕业生出国留学深造率全国排名第一。在软科2018年“中国最好大学”排名中, 学校在财经类大学中排名第一。

UIBE现有全日制学生16000余人, 其中包括来自于160个国家的3400余名来华留学生。学校是中国高校中唯一一所成立“留学生创业就业指导中心”的高校, 已与百余企业建立了合作关系。毕业生以专业知识和技能扎实、语言能力强、思维活跃、实践经验丰富而广受社会的欢迎, 就业方向主要为政府机构、金融机构、驻外商务机构及跨国公司, 他们为促进各国经济与社会发展发挥着重要作用。

## 三、专业培养与学位授予

1. 专业名称: 国际金融专业(硕士)

2. 培养模式:

- 1) 课堂教学: 考虑到学员组成的特殊性, MIF项目将采取课堂讲授、案例研讨、讲座、导师指导等多样灵活的形式实施教学计划;
- 2) 商务考察: 为增进学员对中国金融及商业环境的了解, MIF项目将有计划地安排学员赴中国金融监管职能部门、商业金融机构、经济技术开发区、电子商务企业、互联网金融企业考察;
- 3) 文化体验: 除每月一次的京内或京郊文化之旅外, MIF项目将有计划地组织学员赴京外参加中国文化体验活动。

3. 课程设置和学分要求:

- 1) 课程设置强调理论与实践相结合, 以提高学生解决实际问题的能力;
- 2) 该全日制硕士课程包括必修模块、选修模块, 获得硕士学位最低学分要求为30学分。其中: 必修课20学分, 选修课10学分。

4. 学位授予: 完成培养方案规定的全部课程并取得相应学分, 完成硕士学位论文, 并通过论文答辩的项目学员, 将获得由对外经济贸易大学颁发的经济学硕士学位。

## 四、学制及授课语言

1. 学制: MIF项目学制为1+1模式, 即该项目学员第一学年在对外经济贸易大学完成全日制基础课程学习与考察研究工作, 并完成学位论文的准备工作, 第二学年回所在国结合其自身本职工作实际, 完成学位论文, 并按学校要求来华进行学位论文答辩。每学年分为两个学期, 分别为秋季学期和春季学期。

秋季学期: 9月初——12月底 (共14周)

春季学期: 2月下旬——5月底 (共14周)

2. 授课语言: MIF项目授课语言为英语。

## 六、申请条件、报名时间、流程、申请材料、录取及联系方式

### 1. 申请条件:

项目申请人应符合以下基本条件:

- 1) 年龄原则上不超过45周岁(截止本年度9月1日), 身心健康;
- 2) 具有本科及以上学历, 有三年或以上工作经历; 具有与所申请项目相关专业学习或工作背景者优先;
- 3) 亚洲基础设施投资银行成员国的政府中、高级官员, 金融机构和企业的中、高层管理人员;
- 4) 英语水平良好, 能熟练使用英语从事专业课程学习;
- 5) 具备本领域的职业发展潜能, 有意致力于推动所在国与中国的友好交流与合作。

### 2. 报名时间:

每年1月1日至4月15日。

### 3. 报名流程:

1) 申请人登录“国家留学基金委来华留学网上报名系统”(登录<http://www.csc.edu.cn/laihua>或<http://www.campuschina.org>后, 点击“网上报名学生入口”图标进入)填写申请信息, 在线提交并打印《中国政府奖学金申请表》。请选择留学项目种类Type B, 我校“受理机构编号”为10036。中文或英文填写此表格, 电脑打印, 手写视为无效。

2) 申请人登陆“对外经济贸易大学网上报名系统”(登陆<http://sie.uibe.edu.cn>或<http://www.uibe.cn>, 点击在线报名图标)填写申请信息, 在线提交并打印《对外经济贸易大学外国来华留学生入学申请表》。

3) 建议使用火狐或谷歌浏览器。

4) 申请者须按以下“申请材料”清单的要求准备相应材料扫描件, 并在规定时间内提交至申请机构。

### 4. 申请材料: 申请者需提供以下材料的清晰扫描件。

- 1) 申请者本人签字的申请表, 贴2寸近照(电脑填写, 手写无效);
  - 2) 个人陈述(500字以上);
  - 3) 个人简历(英文版);
  - 4) 学士学位证明和成绩单;
  - 5) 所在单位负责人或副教授职称以上学者的推荐信两份(需写明推荐人电话及email地址);
  - 6) 在职证明;
  - 7) 提供TOEFL 86分或IELTS 6.0分以上考试成绩, 或官方英文水平证明函, 或通过对外经济贸易大学教师的电话测试;
  - 8) 申请者个人普通护照复印件(个人信息页, 护照必须为个人普通护照);
- 提示: 申请阶段只需提供上述文件的扫描件, 入学注册时需提交原件或公证件, 原件或公证件将由学校作为学生档案保存, 不予退还。各种证明、证书须是中文或英文的原件或公证件。申请材料恕不退还。

### 5. 录取:

- 1) 招生委员会将根据申请材料进行审核, 择优确定录取名单。
- 2) 每个奖学金获得者只能获得一个中国政府奖学金项目资助。
- 3) 录取通知书、外国留学人员来华签证申请表(JW201表)将由学校或所在国大使馆转交至学员本人。
- 4) 不能按录取期限来华学习者, 奖学金资格不予保留。

## Program Introduction

Master of International Finance (MIF) program is one of the Youth of Excellence Scheme of China (YES CHINA) master programs sponsored by Chinese government scholarship. It is a key program entrusted by Chinese Ministry of Education to the University of International Business and Economics (UIBE).

This program is for senior governmental officials and senior business managers from the member country of the Asian Infrastructure Investment Bank (AIIB). It goes with China's national strategy of One Belt and One Road, aiming to provide talent support for accelerating the economic development and regional economic integration of Asian countries, as well as to reserve talent resources for AIIB to develop its continuous core competence among international multilateral financing institutions. The program is focused to train policy makers and executors with global vision for regional cooperation, financial administrative talents to accelerate the integration of Asian economy, and entrepreneurs to promote the communication and cooperation within Asia.

The program mainly relies on the School of Banking and Finance of University of International Business and Economics for its strong faculty and rich experience in teaching. After one-year's study (taught in English), students will have a systematic command of theory and practice on developmental international financial cooperation, gain a better awareness of the One Belt One Road national economic environment, and get a deeper understanding of the Chinese finance, law, culture and politic system.

## Introduction to UIBE

The University of International Business and Economics (UIBE), situated near the Olympic Business Center of Beijing, was founded in 1951. UIBE is a national key university under the leadership of the Ministry of Education and the Ministry of Commerce, and is one of the first batch of universities to be included in "project 211", also participated in the "Double-First Class" initiative.

UIBE pursues to be an outstanding national university and a prestigious international university with its distinct characteristics. UIBE has already become a multi-disciplinary university specialized in the fields of economics, management, liberal arts, law and science, and competitive in the subjects such as international trade, international law, finance, business management and foreign languages. UIBE is the first university in possession of both Chinese and English instructional systems at the undergraduate and postgraduate levels. At present, the university offers nearly 84 majors to overseas students of bachelor, master and doctoral study. Among them, 29 majors are offered entirely in English. UIBE is at present the only economic university in China which has been granted with four accreditations as EQUIS, AACSB, CAMEA and AMBA. In terms of AACSB, we are the first entitled university among the "project 211" institutes. Being the only university with "Career Advisory Center" for International students, UIBE has established cooperative relationships with over 100 famous enterprises. In 2018, we ranked the 1st on the ratio of currently studying International students to Chinese students among all China universities, the 2nd place in employment rate, 1st place in the terms of payment increase for graduates, and 1st place on the rate of Chinese graduates studying abroad. In the 2018 ranking of "China's Best Universities" held by ShanghaiRanking, UIBE ranked the first place among economic universities.

UIBE has a total enrollment of around 16,000 full-time students including more than 3,400 international students from 160 countries. As always, UIBE students are widely welcomed by society for their sound professional knowledge and skills, strong linguistic ability, active thinking and rich practical experience. UIBE graduates have been mainly employed in government departments, multinational corporations, financial sectors, large-scale foreign trade corporations and commercial institutions stationed abroad. They are playing an important role in promoting global economy and social development.

## MIF Program

**1. Program Name:** Mater of International Finance (MIF)

**2. Training mode:**

- 1) Class Teaching: Considering the particularity of the composition of participants, MIF program adopts lectures, case studies, speeches, tutoring and other forms of flexible and diverse teaching methods;
- 2) Business Visits: To enhance participants' understanding of the Chinese financial and business environment, MIF program provides regular arrangements for trainees to visit Chinese financial supervision departments, commercial financial institutions, economic development zones, E-commerce enterprises and internet financial businesses;
- 3) Cultural Experience: In addition to a monthly trip to rural suburbs of Beijing, MIF program also plans arrangements and study tours for participants to go out of the capital to experience Chinese culture.

### 3. Curriculum and Credits:

- 1) Combined with theoretical and practical teaching, the curriculum is designed to enhance students' problem-solving abilities.
- 2) The curriculum of this full-time master program includes a compulsory module (20 credits), an optional module (10 credits) and a practical module (4 credits). One should acquire 34 credits to get the diploma.

### 4. Degree Granted:

Program participants who have acquired 34 credits, accomplished all the courses, completed the master degree theses and passed the thesis defense will be granted a Master diploma of economics by UIBE.

## Academic structure and Teaching Language

**1. Academic structure:** "1+1" mode, the first academic year for studies, business visits and thesis writing in UIBE, the second academic year for practical work (back home) and thesis defense (in UIBE). Every academic year is divided into two semesters, fall semester and spring semester.

Fall semester: early September - the end of December (14 weeks)

Spring Semester: late February - the end of May (14 weeks)

**2. Teaching Language:** English.

## Admission requirements, Application period, Application procedure, Application materials and Admission

### 1. Admission Requirements:

- 1) Age under 45 years old (by Sep. 1, current year), with good physical and psychological health.
- 2) Bachelor degree or above, with 3 years working experience. Those with related education or working background will be preferred.
- 3) Senior governmental officials or senior management staff of financial institutions from the member country of the Asian Infrastructure Investment Bank.
- 4) English good enough to take courses taught in English.
- 5) Be potential in related professional development and willing to promote communication and cooperation between China and other countries.

### 2. Application Period

Jan. 1 - April. 15 each year

### 3. Application Procedure

- Applicants shall make online application at <http://laihua.csc.edu.cn> (Choose Program Category Type B and the Agency No. of UIBE: 10036) download and print out the Application Form for Chinese Government Scholarship and then sign the form. Hand-writing version is invalid.
- Applicants are required to make another online application at <http://sie.uibe.edu.cn> or <http://www.uibe.cn>. Please download and print out the International Student Application Form generated upon successful online application.
- Please use Firefox or Google.
- Please Submit the application documents (legible scanned ones) listed below to the application receiving agency.

### 4. Application Materials

An applicant should submit the scanned copies of the following documents:

- Application Form for Chinese Government Scholarship with a 2-inch photo and the applicant's signature.
- Personal statement of research (A minimum of 500 words in English).
- CV in English
- Copies of bachelor's degree certificate(s) and academic transcript(s).
- Two recommendation letters from the applicant's employers and/or professors.
- Telephone numbers and email addresses of the referees must be included in the letters.
- Employment verification.
- A copy of TOEFL 90 above or IELTS 6.0 above or official letter of English proficiency, or passing the telephone test by UIBE faculty.
- Copy of the passport page of personal information.

Note: Scanned copies of the documents will be sufficient during the application period. Originals or verified copies will be required upon enrollment at the universities. All documents should be in Chinese or English and be originals or notarized copies. All documents are not retrievable.

### 5. Admission

- 1) The admission committee will review the application materials and decide the admission list.
- 2) Every candidate can be enrolled in only one Chinese government scholarship sponsored program.
- 3) The admission notice and visa application form for study in China (JW201) will be delivered to students by UIBE or through corresponding embassy.
- 4) The scholarship will not be reserved for those who cannot come to study on time.
